

LETTER OF ASSURANCE REGARDING UNITED STATES EXPORT REGULATIONS AND END USER / USE STATEMENT



COMPLIANCE WITH EXPORT REGULATIONS

The undersigned, ("the Company") understands that the products, technology and services associated with the Purchase Order referenced below ("Thermon Products") may be subject to the export control laws of the United States and other countries. Export, reexport, use or diversion contrary to applicable law is prohibited.

The Company understands that its sale or distribution of Thermon Products may constitute an export or reexport of goods of U.S. origin or content, and as such, must be in accordance with the requirements of U.S. export control laws. It is understood that the end-user, end-use, or country of ultimate destination of any Thermon Product could affect the applicable license requirements and exportability. The Company agrees to consult appropriate resources to ensure that the sale and distribution of Thermon Products is done in accordance with applicable laws and regulations.

SPECIFIC PROHIBITED END-USERS

RESTRICTIONS ON END-USE

The Company understands that there may be restrictions on the ability to supply Thermon Products for specified end-uses, as regulated by part 744 of the U.S. Export Administration Regulations, without prior U.S. government authorization. The Company understands that Thermon Products may not be used, directly or indirectly, in any of the following

SPECIFIC PROHIBITED DESTINATIONS

U.S. law prohibits the export, reexport, or transshipment of U.S. origin products to certain destinations without an export license. The Company agrees to consult appropriate resources, such as the U.S. Federal Register, to review the list of current embargoed or severely sanctioned countries and to understand and comply with the specific restrictions on the export or reexport of U.S. origin products under this embargo and sanction policies.
